Bright Smiles Hawaii Project Update

Bright Smiles Hawaii (BSH) is an initiative of the Hawaii Public Health Association and was established in 2016 with a \$150,800 grant from the DentaQuest Foundation. The BSH mission is to broaden the dialogue on oral health issues among federal agencies, state organizations and community partners to integrate perspectives, and bridge cultural oral health issues, barriers, and strategies.

Accomplishments:

- Established Oral Health Disparities Community Advisory Network which includes representatives from the DOH and DOE, among others.
- Four Community Innovation Awards have been granted in oral health outreach, education, and information gathering in at-risk communities.
- BSH website provides resources and information about BSH and OH in Hawaii www.brightsmileshawaii.org
- BSH's statewide OH Disparities Survey resulted in over 700 survey responses; analysis and reporting is available
 on our website. Through BSH, HPHA strives to improve the public perception of the value of oral health to
 overall health.
- Work focuses on the neediest, most at-risk and disadvantaged populations.
- Overall goal is to support a more inclusive and responsive collaboration that will result in better oral health outcomes for all residents of Hawaii.

Proposed Revisions to the Constitution and Bylaws

The following bullet points outline the substantive changes proposed in the revised C&B:

- Adds the Vision & Values language with the Mission (page 1).
- The Vice President (VP) no longer automatically succeeds to the President's office at the conclusion of the VP's term, and the VP term length increases from 1 to 2 years (page 3).
- The President's term length increases from 1 to 2 years. The position of the Immediate Past President (1-year term) is retired and removed from the C&B (page 3).
- The Affiliate Representative to the Governing Council (ARGC) of the American Public Health Association (APHA) becomes a member of Officers (page 3).



- Adds language specifying the staggering of Officers' terms—"The election for President shall be held in even years, whereas the election for VP, Secretary, and Treasurer shall be held in odd years" (page 3).
- Adds Ex-Officio Director seats to the HPHA Board for the (page 4):
 - o Director of the Hawaii State Department of Human Services
 - o Directors of academic institutions that offer graduate-level public health programs
 - o (e.g., University of Hawaii at Manoa's Office of Public Health Studies, Hawaii
 - Pacific University's Department of Public Health)
 - Presidents of student clubs/organizations from academic institutions that offer
 - o graduate-level public health programs (e.g., University of Hawaii at Manoa's Hui
 - Ola Pono, Hawaii Pacific University's Public Health Club)
- Authorizes the Executive Director as a co-signatory for bank checks (page 6).
- Separates the singular Committee on Programs and Member Services to two separate committees (viz., Committee on Programs, and Committee on Member Services; page 10).
- Adds language that the Committee on Legislative & Government Relations—in order to expediently provide time-sensitive testimonies—needs only the approval of 1) the committee chair and 2) the majority of Officers. For all other non-time-sensitive matters, as written on the current Bylaws, the committee needs the approval of the majority of the Board (page 11).
- Resurrects the Committee on Marketing & Public Relations (page 11)

A member requested that votes be counted to confirm at least 2/3 vote of attending members. A vote was conducted. Vote count: 42 Yays, 0 Nays, 2 Abstained. The proposed revisions to the Constitution and Bylaws were passed.
