HPHA Changes to Constitution

submitted to general membership for consideration on 9/24/19

- > Change Vice President to President-Elect; President-Elect is a 1-year term with obligation to assume the presidency for a second 1-year term.
- > Stagger terms of officers to facilitate leadership succession and avoid turnover of the majority of officers in a single year: Secretary is elected in even years, starting in 2020; President-Elect and Treasurer are elected in odd years. Secretary and Treasurer remain 2-year terms.
- > Change ARGC from an elected officer to an appointed officer.
- Add two (2) Director-At-Large seats, open to any island; both seats serve a 1-year term.
- Add two (2) Student Directors, open to undergraduate and graduate students from any program within the interdisciplinary scope of public health practice. Student Directors shall be appointed by the President, with approval of the Board, for a 1-year term (January December).

 Note: A competitive application process will facilitate Student Director appointments.
- Change Ex-Officio Directors (i.e. appointees) from voting to non-voting members. Add language providing voting privileges for Ex-Officio Directors at the discretion of and by majority vote of the Board of Directors.
- In light of the two Student Director positions added to the Board, eliminate Ex-Officio positions (2) designated for the presidents of the student public health clubs at HPU and UH.
- Add language to the Constitution allowing for amendments between Annual Meetings, consistent with language already in the Bylaws.



HPHA Changes to Bylaws

submitted to general membership for consideration on 9/24/19

- ➤ Change the Vice President position to President-Elect.
- Add language clarifying that the Board of Directors shall: act in in the best interest of the Association; serve as a member of one or more committees; and participate in regular meetings of the Board. Add language clarifying that absence of three meetings per calendar year constitutes resignation from the Board. Ex-Officio Directors are excluded from this requirement.
- ➤ Delete language requiring that the Board of Directors "indicate the date, time, place and registration fee (if any) of the Annual Meeting" as this language is repeated elsewhere in the Bylaws and Constitution.
