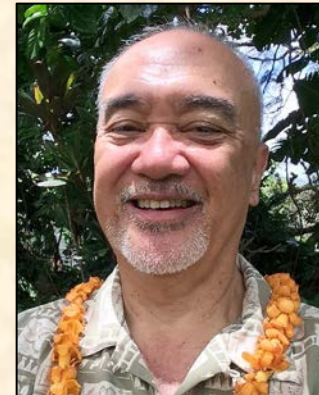

- Submitted 15 testimonies on 11 bills relating to four priority areas:
 - Climate & Health/Community Resilience
 - Healthy Foods
 - Behavioral Health
 - Workforce Development & Training

Committee on Governance

- Developed a timeline, process and slate of candidates for 2020 BOD elections – HPHA’s first virtual election in its 75 year history.
 - 6 open seats beginning January 2021:
 - President-Elect (open to members on all islands), 1 yr term + 1 yr as President
 - Secretary (open to members on all islands), 2 yr term
 - Director At-Large (open to members on all islands), 1 yr term
 - Director At-Large (open to members on all islands), 1 yr term
 - Director At-Large (open to members on all neighbor islands), 2 yr term
 - Director At-Large (open to members on all neighbor islands), 2 yr term
 - Elections closed on 10/16; *results will be announced at HPHA’s Annual Meeting, Nov 12*
- Identified need for a minor amendment to **HPHA’s Constitution, Article IV, Section 2:** “With exception of the ARGC, the Officers shall be elected at the Annual Meeting of the Association for two-year staggered terms (from January to December). The election for President-Elect shall be held annually. The election for ~~and~~ Treasurer shall be held in odd years, whereas the election for Secretary shall be held in even years.”

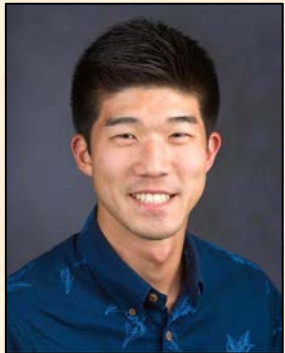

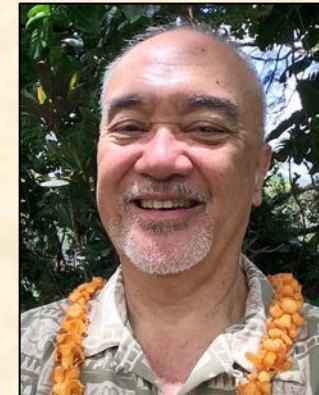
